AMAKIN Holds its Ordinary General Assembly Meeting of 2023

Bahrain Car Parks Company (AMAKIN), listed on Bahrain Bourse and traded under (CPARK), recently held its Annual General Assembly Meeting at the Business Center of Bahrain Bourse at Bahrain Financial Harbour. The AGM was chaired by Mr. Amin Alarrayed, Chairman of the Board of Directors.

The minutes of meeting for ordinary general meeting, held on 26th March 2023, were discussed, and approved. The financial statements for the year ended 31st December 2023 were also ratified. The AGM approved distribution of 8% of the paid-up capital as dividends to the shareholders (except treasury shares), equal to BD874,421 i.e. 8 Fils per share for the year ended 31 December 2023.
